# THE SPIRIT OF ANTI-CHRIST IS ALIVE AND WELL

Baptist, Pentecostal and other denominational pastors and televangelists push pre-millennial theories and frighten people with wild tales about the rise of a future dictator known as the great "Antichrist," who will seek to destroy Israel.
